The National Federation of the player can also submit the entry form on her behalf. Players are responsible to check if their entry form has been accepted.

The entry fee must be paid at registration in the Golf Club. Handicap limit is 6.4. The list of participants will be published on 7 October at www.rfegolf.es. Any claims must be submitted within the next 24 hours.

IMPORTANT NOTE FOR PARTICIPANTS:

*The championship will take place under the security measures against COVID19 and **THE OFFICIAL COMPETITION GUIDELINES OF THE RFEG.***

Among these measures, a VIRTUAL scorecard will be used. Each participant will receive a link from which they will have access to their scorecards throughout the tournament. The sending of this unique link - which each participant must keep private - will be done by SMS to the mobile phone number indicated in the online registration, and will be used to enter your results and those of the player who scores. The National Federations that register players have to indicate the email address and mobile number of each player when registering.*

***The player must ensure that both her mobile phone number and her email address - which appear on the online registration screen - are up to date.** If they are not correct, the player can change them by accessing, on that same screen, to "Edit Personal Information", save new data and then return to "Online registration". However, the player may request the tournament office to send a new access link or update her mobile number if necessary.*

It is recommended that players enter the results hole by hole, make sure they have their mobile fully charged at the beginning of each day, keep it muted at all times and in plane mode while no data is entered.

**Exceptionally, disinfected scorecards will be available for those players who might need them.*

WITHDRAWALS:

Notifications of withdrawal must be made by phone or email to rfegolf@rfegolf.es by 12:00 am two days before the competition starts. **From Monday 25 of October, 2021, only the players on the waiting list who have confirmed availability to play by email to elena.vecino@rfegolf.es, will be called to cover last-minute withdrawals. The players who have not done so will be definitively withdrawn.**

ACCREDITATIONS AT THE CHAMPIONSHIP OFFICE:

Players must register from 8:30 hours to 14:00 hours of October 28. As part of the registration in the club, the RFEG will require each participant to deliver to the Championship Committee:

- A **negative COVID test** (to be carried out free of charge at the entrance of the club, before accessing it)
- The **Responsible Declaration** (pages 7 & 8)
- The **Personal Location Form** (page 9), duly completed in all its sections and signed.

Whoever fails to comply with this requirement will not be able to participate. In the same way, technicians, federation and, must deliver both duly completed documents to the Championship Committee.

Once the accreditation is completed, the player must pay the entry fee of **75,00€*** to complete the registration and access the Golf Club's facilities.

Technicians, Officials and members of National Federations, organization personnel, and a **single companion per player** must be accredited upon arrival at the tournament office, presenting the documentation required for registration to obtain the accreditation to access the club's facilities

**This fee includes the temporary license required by the RFEF Statutes and the insurance attached to the license, subscribed by the Regional Federation where the competition takes place.*

DMD's and audio and video devices: Rules 4.3a (1) and 4.3a (4) are modified in the sense of prohibiting their use.

ELECTRIC TROLLEYS:

The Golf Club has availability of electric trolleys. Players can book them by email to montecastillo.golf@barcelo.com **before** . Bookings will be awarded on a first come first served basis.

NATIONS CUP:

Attached you will find the appropriate Entry form (page 5). National Federations are required to send their team/teams by the closing date.

DRESS CODE:

The player is responsible for compliance with the Dress Code of the Club where the competition is held or, failing that, for wearing appropriate clothing.

ANTI-DOPING POLICY:

All players are subject to the provisions of the International Golf Federation's Anti-Doping Policy. Details of the Policy and the current List of Prohibited Substances and Methods are available from the International Golf Federation's website (www.igfgolf.org). Players who are taking medication and in doubt as to their clinical status should seek advice from the IGF knowing that, should a Therapeutic Use Exemption (TUE) be required this must be submitted to the IGF not later than 30 days before the start of the Championship. CONDITIONS SPANISH LADIES' STROKE PLAY CHAMPIONSHIP

Eligibility:

Open to all women amateur players who are members of a recognised Golf Union or Federation. Handicap limit is 6.4. The exact handicap certified at the date of entry will be used for all purposes. Entries are limited to the **73 competitors with the lowest exact handicap**. In case of tie on the 73rd position, the player registered earlier will be included. A waiting list will be established with the excluded players in order of exact handicap. The criteria to be followed to establish the order of priority, among the players on the waiting list with the same exact handicap, will also be that of the earliest registration date.

The Women's Technical Amateur Committee reserves the right to increase the starting field by 5 invited players.

Withdrawals must be notified to the Ladies Amateur Technical Committee at the RFEG by 12:00 am, two days before the competition starts. Players who violate this condition will not be able to participate in the next edition of this championship. In addition, they will be obliged to pay the entry fee or they will no longer be able to participate in any RFEG competition until this payment is cleared.

Format:

Three Stroke Play Scratch rounds of 18 holes shall be played. Only players returning the 50 lowest scores over 36 holes shall qualify for the final round.

Ties for the Championship title will be decided by a sudden-death play-off over the holes previously established by the Championship Committee. If the holes are not announced, the order will be the stipulated round. Ties for the rest of the awarded positions will be solved by card count back using the last 27, 36, 45, 48, 51, 52 and 53 holes; if still a tie, it will be decided by lot.

Entries:

Entry forms shall be submitted to the Royal Spanish Golf Federation by the announced closing date. Entry fees shall be paid upon registration at the Championship venue.

Prizes:

The Champion, second place and third place will receive trophies. A memento will also be given to the best qualified player u-18. Prizes will be non-cumulative.

The Championship Committee reserves the right to alter the regulations and conditions of the competition.

NATIONS CUP

A minimum of one team from five different countries must be registered for the celebration of the Nations Cup. Each team shall consist of two or three players designated by their National Golf Union or Federation. A maximum of three teams per country will be allowed.

Format: Aggregate of the two lowest scores on each of the three Stroke Play rounds. Ties will be resolved by taking into account the aggregate of the non-counting scores; if still tied, the team with the best finished individual player will be proclaimed the winner.

Each member of the winning team will receive a trophy.

All prizes will be donated by The Royal Spanish Golf Federation. No other prizes shall be donated without the Spanish Women Amateur Committee's consent.

RESPONSIBLE DECLARATION

Spanish International Ladies' Amateur Stroke Play Championship 2021

Mr./ Mrs. of legal age and with ID.with telephone number domiciled at in own name or as father / mother / legal guardian of the minor..... with federated license number issued by the National Federation. I appear and manifest as best appropriate.

I DECLARE UNDER MY OWN RESPONSIBILITY

1. That I have full knowledge and awareness that the practice of the sport of Golf both in training and in meetings implies a risk contagion of COVID-19 of which I am aware and accept, with the understanding that I will have the right to be able to present the appropriate claims against those people who have breached the protection and communication rules established in the protocols, especially when they have been an athlete who have participated in the meeting.
2. That I do not present compatible symptoms with the SARS-CoV-2 Coronavirus (fever greater than or equal to 37.5 degrees, cough, general malaise, feeling short of breath, loss of taste, headache, fatigue, neck pain, pain muscle, vomiting, diarrhoea) or any other typical symptoms of infections.
3. That I have not tested positive or had close contact with any person or persons with possible or confirmed symptoms of COVID-19 in the 14 days immediately prior to the date of signing of this document.
4. That I have read the security protocols and the information and prevention measures for hygiene and security of COVID-19 established by the organizer of the competition and the meeting and I agree to comply with them in a responsible manner, in their entirety, with the guidelines of conduct and behavior that are established there, accepting that the Hygiene Manager of the event can agree on his own accord my exclusion from the competition and from the installation or limited area of the sports space in case of non-compliance.
5. That I am aware and accept that non-compliance with the rules of COVID-19 especially the non-declaration of having tested positive or not having declared the fact of having had a close relationship with people with symptoms implies a very serious infraction of the disciplinary code that can lead to a sanction of exclusion from the competition and the loss of the sports license for the entire season.
6. That I promise to inform the club and the Federation (before any match) of any symptoms that are compatible with COVID-19, the fact of having tested positive or the existence of any presumed or confirmed case of covid-19 in the family or close environment and I promise to keep the club managers promptly informed of their evolution.

This information will be treated confidentially and for the sole purpose of being able to adopt the necessary measures to prevent the contagion and spread of the virus. By completing this document, the undersigned grants express consent for the Spanish Golf Federation to process these data from a strictly medical point of view and prevention.
