**ADDITIONAL LOCAL RULES**

In addition to the R&A Rules of Golf and the Permanent Rules of the Ffgolf, the following Additional Local Rules apply. These rules cancel and replace any other local rule of the Golf Club de Lyon Parcours les Sangliers.

**OUT OF BOUNDS (R 18.1)**

- The Club House, the Terrace and the Parking are out of bounds
- **Hole n°5** on the left and **Hole n°13** on the right (out of bounds barely visible from the teeing area).

**ABNORMAL COURSE CONDITIONS INCLUDING IMMOVABLE OBSTRUCTION (R 16.1)**

- **Immovable obstructions** :  
**Hole n°5**: the wooden walls and artificial faces of the bunker.  
 If the ball is in the bunker and if such wooden wall or artificial face interferes with the ball, the player's area of intended stance or area of intended swing, the player may take a free relief under R 16.1c  
**Additional option (DZ under R 14.3)**, the player may take a free relief by dropping a ball in the bunker at one club-length (Size of Relief Area Measured from the green stake).
- **Ground Under repair**:
  - Bare or cracked ground on the greens.
  - If the ball is on the green, a seam of cut turf is upon the player discretion:
    - either an abnormal condition under R. 16.1.
    - or a damage that the player is allowed to repair.
  - Any area bounded by a white line (dots).

**INTEGRAL OBJECTS**

- All paths and roads whatever the covering material.

**PENALTY AREAS (R 17)**

- When the edge of a body of water is not defined by the Committee, the edge of that **penalty area** is defined by its natural boundaries (that is, where the ground slopes down to form the depression that can hold the water, or where the ground slope breaks or at the mowing edge)
- **Hole 6** : the penalty area on the left extends infinitely.

**PREFERRED LIES (Model Local Rule E-3)**

When a player's ball lies in a part of the general area cut to fairway height or less, the player may take free relief once by placing the original ball or another ball in and playing it from this relief area:

- **Reference Point**: Spot of the original ball.
- **Size of Relief Area Measured from Reference Point**: **one score card length** from the reference point, **but** with these limits
- **Limits on Location of Relief Area**: Must not be nearer the hole than the reference point and must be in the general area.

**SPECIAL CONDITIONS Stroke Play:**

**Pace of Play Policy:**

As per the Committee decision, the maximum time allotted for the completion of 18 holes at Les Sangliers is **4h45**, including the time to go to the recording area. **Pace of Play Policy will be strictly enforced.** The players are encouraged to play « Ready Golf ».

**Reminder:**

If a referee is not available, a player who is uncertain about the right procedure while playing a hole may complete the hole with two balls without penalty under R 20.1c(3). The player must report the facts of the situation to the Committee before returning the scorecard, even if the player scores the same with both balls. Failing to do so, the player is disqualified.

**Drinkable water: club-house – teeing areas Hole n°1, 2, 8, 10 - green Hole n° 14, 16**

Please replace your divots, rake the bunkers, repair your ball marks. Thank you.
